ARS & AAOHNS Rhinology and Allergy Education Committee

The Rhinology and Allergy Education Committee (RAEC) is one of the standing subcommittees of the Educational Steering Committee of the AAOHNS. As such, it is charged to design, develop, and implement continuing education materials that fulfill the CME mission of the foundation. The committee's focus oversees the development and restructuring of some of the current AAOHNS educational material that deals with disorders of the nose, and paranasal sinuses both medically and surgically. Specifically, the committee reviews development of modules relating to rhinosinusitis both acute and chronic, allergic rhinitis, the evaluation and management of nasal septal deformities, perforations and CSF rhinorrhea and other modules in this domain.

The American Rhinologic Society is well represented on the RAEC. Members include Drs. Todd Kingdom, Brent Senior, Richard Orlandi, Rakesh Chandra, Karen Fong, Nicholas Busaba, Matthew Ryan, Chris McMains, Rhoda Wynn, Fuad Baroody, Samer Fakhri, Douglas Reh, Steven Houser, and Amber Luong.

This committee is responsible for the educational materials utilized by members to obtain credit their Maintenance of Certification and for CME. These include the Home Study Course, Patient of the Month programs, Otolaryngology Online Study Guide (OOSG), modules for COOL (Clinical Otolaryngology Online Learning) as well as specific modules for CME in the Rhinology/Allergy section of Academy U.

With the change in the American Board of Otolaryngology requirements for maintenance of certification status, ARS members are able to utilize the digital educational material in order to complete some of the CME requirements. Additionally, these courses serve as a means to further knowledge as a requisite for the MOC process.

The information in the Home Study Course is evidence-based and can serve as a cognitive review. Section 5 of the Home Study Course in Rhinology and Allergic Disorders was published in September, 2008, under the direction of cochairs: Brent Senior, MD and Erica Thaler, MD. A great deal of work goes into the choice of the articles and preparation of the testing materials and questions so that Academy members attain CME credits. The next Rhinology and Allergy HSC is in progress with Chairpersons Drs. Kingdom and Light with help from Drs. Baroody, Fakhri, Fong, Luong and Reh.

Over the last few years, the RAEC has made a fairly strong transition from the paper products to the digital format providing images and material for Academy U. A new Academy U course entitled management of CSF rhinorrhea is also currently available. It has been edited by Dr. Richard Orlandi and Dr. Rhoda Wynn and serves as a resource for members to review and update their knowledge as a mechanism to obtain credit for their "Maintenance of Certification." Other courses such as Dr. Nicholas Busaba's Patient of the Month program on Nasal Septal Perforation is about to be published.

Under the direction of Dr. Chris McMains, this committee is also represented on the Academy's working group to develop CT imaging curriculum. These courses will assist in members obtaining appropriate accreditation to be able to utilize CT scanners in the office. Other Academy annual meeting presentations are being videotaped for inclusion in the listing of educational materials available for members. They are succinct both audio and visual presentations that complement the CME activities.

The RAEC Committee has been working on other projects as well. The COOL module: Office Management of Nasal Congestion has been updated by Drs. Steven Houser and Evan Reiter. Patient of the Month programs are in progress and the committee also was active in the submission of the Questions for the Academic Bowl during annual meeting.

Case of the Quarter: Pituitary Apoplexy




Figure 1. Axial and coronal post-contrast MRI.




Figure 2. Preoperative and postoperative visual field tests. Darker shades of gray correspond to vision loss.

A 47 year-old female presented to the emergency department with a three-day history of worsening headache and vision loss. On further questioning, the patient had been suffering from mild daily headaches for one year, and had an unrecognized loss of peripheral vision. Gross visual field deficits were noted on examination. The remainder of

her examination was normal. A CT scan was performed, suggestive of a large sphenoid mass. MRI scan further delineated this mass as a pituitary lesion with a cystic center (Figure 1). Laboratory values demonstrated hypothyroidism, without any other abnormality. The ophthalmology service was consulted; visual field analysis is demonstrated in Figure 2.

The patient was admitted to the hospital and treated for 72 hours with intravenous glucocorticoids. Endoscopic transsphenoidal pituitary surgery was then performed in collaboration with the neurosurgery service. On dural entry, blood clot and fluid were decompressed, consistent with pituitary apoplexy. Subtotal resection of a nonfunctional pituitary adenoma was performed.

The patient's vision began to recover postoperatively within 48 hours; postoperative visual field examination is seen in Figure 2. The patient was treated medically with hydrocortisone and levothyroxine postoperatively.

Pituitary apoplexy is a clinical syndrome resulting from sudden expansion of a pituitary tumor due to hemorrhage, infarction, or both. Symptoms may include sudden onset of headache, vomiting, vision change, ophthalmoplegia, and altered mental status. Pituitary apoplexy occurs in 0.6-9% of pituitary tumors, depending on the definition used, and is a common initial presentation for pituitary tumors.1 CT scan and MRI are diagnostic, and are recommended for any patient presenting with headache and neuro-ophthalmic signs. As many patients are deficient of one or more pituitary hormones, timely diagnosis and medical therapy may reduce morbidity and mortality. The initial medical management consists of supportive care, fluid and electrolyte balance, and replacement of corticosteroids and other deficient hormones. The timing of surgical decompression in the setting of visual compromise is controversial. The literature supports initial medical management for pituitary apoplexy, with prompt surgery reserved for patients with severe neuro-ophthalmic signs that do not respond to medical therapy. 2 Review of the literature suggests that visual prognosis for blindness

associated with pituitary apoplexy is poor. However, as seen in this case, early surgical decompression may offer better visual outcomes than surgery occurring more than 1-2 weeks after ictus.3 Recovery of endocrine function in the setting of apoplexy is uncommon with either medical or surgical management.

Update on Rhinology Fellowship Match Process

The ARS Education and Fellowship Committees continue to oversee the Rhinology Fellowship match process in conjunction with the San Francisco Match Organization. The 2010 Match for training spots beginning July 2011 was recently completed in early June 2010. This was our 5th cycle utilizing the SF Match Organization, though refinements to the process continue, growth has been significant and the successes evident.

Support for this process remains strong amongst the program directors, ARS Board of Directors, and applicants. The number of participating fellowship programs remained stable at 22 but the number of positions offered grew to 24. Forty-two applicants initially registered for the match, the greatest number ever, with 33 ultimately submitting rank lists and formally committing to the match. Twenty-two applicants matched (19 US graduates / 3 international) into 20 programs (2 programs did not fill their spots / 2 programs matched 2 applicants each). Overall 75% of programs matched one of their top three ranked choices while 68% of applicants received one of their top three selections. Future efforts will include continued refinements to the web-based and electronic methods for communication amongst program directors, applicants, and the SF Match. With our current structure, the Fellowship Committee is functioning as an ad hoc committee reporting to the ARS Board of Directors through the Education Committee of the ARS. This group meets twice yearly to closely monitor the process and meet the evolving needs of the program directors and applicants.

Point of Service Imaging in Rhinology

Point of Service (POS) Imaging in Rhinology was the topic for an ARS Breakfast Symposium prior to the annual meeting in San Diego.

Dr. Brent Senior kicked off the symposium highlighting the developing controversy about POS imaging from the radiology and payer sides. In just a few years there has been a large increase in private office CT volume, combined with a resultant push back from ACR and third party payers. Most of this volume and activity is actually being driven by other specialties. Challenges that lie ahead will be the new CMS rules requiring certification by 2012 and the drop in the physician fee schedule proposed for 2010.


Dr. Michael Setzen discussed "Incorporating POS CT in your practice". From a patient care perspective, a number of benefits are immediately evident with the change to office based scanning. These improvements in care include: facilitation of early diagnosis and appropriate treatment, improved patient compliance (3 visits in 1), less time away from work, school and family, enhanced patient and referring physician satisfaction, better patient/doctor relationship and diagnosis comprehension when reviewing the images together, and enhanced practice revenue.

Dr. David Conley addressed the "Impact of POS Imaging on treatment of rhinosinusitis". Preliminary data from a prospective randomized trial was presented. In this study, patients who meet the AAOHNS Task force criteria for chronic rhinosinusitis and have a normal endoscopic examination were randomized to a POS CT scan or the standard course of antibiotics. Analysis indicates that the arm randomized to POS CT reduced unnecessary antibiotic use, and may even be more cost effective. Further analysis will be presented when the study is complete.

Finally, Dr. Martin Citardi presented "Expanding indications for POS Imaging - Intraoperative Imaging". He feels the ideal intraoperative imaging system would be portable, integrate with existing surgical navigation, provide high quality images, offer minimal risk for patients and staff and carry reasonable costs. Intraoperative imaging is a potential solution to the intrinsic problem that surgical navigation only relies upon preoperative imaging

and does not reflect changes from the surgery. Dr. Citardi presented a series of endoscopic procedures illustrating the added value of intraoperative scanning in complex skull base procedures. Current estimates suggest that intraoperative CT effects change in surgical management in approximately 25-30% of rhinology procedures.

In summary, the integration of a POS CT scanner into a rhinology practice has many benefits for the patient. Appropriate use of this diagnostic tool holds great promise to improve patient care and may reduce unnecessary antibiotic use and may even reduce overall health care costs.


